- a letter of interest;
- a personal biography;
- verification of attendance at SSUNAA Annual Meeting; and
- verification of participation in SSUNAA fundraisers.

Savannah State University National Alumni Association Constitution

Article V- Minimum Qualifications for Elected Officers

Section 1. To be eligible for an elected office, all candidates must meet the following qualification:

A. Must be a member of a local chapter and/or the National Alumni Association for a period of two years prior to candidacy.

B. Must have registered and attended one of the last two annual meetings prior to candidacy.

C. Must have financially supported one of the last three National Fundraising efforts excluding the National Raffle.

D. Must have served a minimum of (2) years in a leadership role on a local, region or national level as an officer, committee chairman or committee member.

E. Must complete the application for candidacy and present to the nominating committee by September 30 proceeding the election year.
